Call for Expression of Interest No.002/AMI/SNH/CIPM/2022 of 14/07/2022 for the prequalification of companies to carry out the construction works of the administrative building and the base camp of the National Hydrocarbons Corporation in Bipaga, by Kribi, Ocean Division, South Region, Cameroon

1) Context

Within the scope of its natural gas exploitation activities in the Kribi area, the National Hydrocarbons Corporation (SNH) intends to build an administrative building and base camp for its staff working in its gas facilities, on a plot of land with a total surface area of five thousand seven hundred and eighty-nine (5 789) m², in Bipaga, by Kribi, in the Ocean Division, South Region, Cameroon.

The detailed studies phase of this Project is currently underway, and the construction phase is expected to begin in the second half of 2022.

2) Scope

The purpose of this Call for Expression of Interest (CEI) is to pre-qualify companies for the construction works of the administrative building and the base camp of the National Hydrocarbons Corporation in Bipaga, by Kribi, Ocean Division, South Region, Cameroon.

3) Conditions for participation

This CEI is intended for companies specialised in building construction works, with their head office in Cameroon.

4) Nature of services

The work covered by this CEI concerns the construction works of a two (2) floors administrative building and a two (2) floors base camp for the National Hydrocarbons Corporation in Bipaga. The works shall notably include:

- Site installation;
- General earthworks;
- Structural work (structure, elevations, plastering and screeds);
- Roofing and waterproofing works;
- Ceiling and false ceiling works;
- Plumbing and sanitary installation works
- Electrical works (high and low voltage);
- Air-conditioning, ventilation and smoke extraction works;
- Floor and wall coverings;
- Wood, aluminium and metal joinery and lightweight walls;
- Installation of a fire safety system;
- Installation of the lift;
- Installation of videosurveillance and access control ;
- Signage work;

- External and landscaping works.

5) Execution deadlines

The time limit for the execution of works is **twelve (12) months**.

6) Consultation and acquisition of the CEI file

The CEI file may be consulted and obtained during working hours, upon publication of this Invitation to Tender, at the Secretariat of the Public Contracts Unit of the SNH, located at its head office building in Yaoundé.

Deadline for the acquisition of the Tender File is **on Friday 05th August 2022 at 3:00 pm, local time**.

7) Pre-bid meeting and visit of the project site

In order to ensure that bidders understand all the aspects of the project and the context in which it is carried out, SNH shall organise a pre-bid meeting and site visit with companies that have purchased the CEI file **on Friday 12th August 2022 at 10:00 am, local time**, at SNH's Liquefied Petroleum Gas Depot in Bipaga, by Kribi.

Companies that have purchased the CEI file are invited to participate in these activities, and the related costs are to be borne by them.

Participation in the pre-bid meeting and in the entire duration of the visit to the project site is compulsory, failing which SNH will not issue a visit certificate.

8) Submission of bids

Each bid, drafted in French and English, should be submitted in a sealed envelope, to the Secretariat of the Public Contracts Unit of SNH, P.O. Box 955 Yaoundé, Tel.: (237) 222 20 98 64, Fax (237) 2 22 20 98 69, **latest Wednesday 07th September 2022 at 02:00 pm, local time**.

9) Opening of bids

The bids shall be opened on **Wednesday 07th September 2022 at 02:00 pm local time**, by the Internal Tenders Board of SNH.

10) Evaluation of bids

To be pre-qualified, candidates must meet all the qualifications required to complete

the The work covered by this CEI. The evaluation of their capacities will be based on the criteria below:

* *Elimination criteria*

- Incomplete administrative file or technical offer, or non-conformity (including that of the members of the Group, if applicable) of one of its documents, subject to an extension granted by the Internal Tenders Board;
- Technical offer score less than eighty out of one hundred points (80pts/100);
- Technical staff of the Bidder not qualified;
- Absence of proof of having already carried out at least two (02) contracts for the construction of a multi-storey building with a built-up area (cumulative floor area) of at least 1 000 m² over the last ten (10) years;
- Financial capacity of less than four (04) billion CFAF;

Only companies whose bids evaluation have not been eliminated and which have obtained a technical score equal to or higher than eighty out of one hundred points (80pts/100), will be prequalified.
